

A BILL OF THE ASSOCIATED STUDENT BODY SENATE TO AMEND TITLE I, SECTION 103 OF THE ASSOCIATED STUDENT BODY CODE, WHICH CURRENTLY READS:

Section 103. Powers and Duties of the Associated Student Body President.

A) The President shall have nomination and appointment powers.

...

D) The President shall have the power to submit the budget of the ASB in the form of an Executive Bill to the Campus Senate for approval.

E) The President shall annually organize a transitional meeting for the student body presidents and presidents-elect of the publicly supported universities of the State of Mississippi. The date of the meeting shall be established prior to ASB Spring Elections and shall be held before inauguration in coordination with the previously stipulated attendees.

TO READ:

Section 103. Powers and Duties of the Associated Student Body President.

A) The President shall have nomination and appointment powers.

...

B) The President shall have the power to submit the budget of the ASB in the form of an Executive Bill to the Campus Senate for approval.

C) The President shall annually organize a transitional meeting for the student body presidents and presidents-elect of the publicly supported universities of the State of Mississippi. The date of the meeting shall be established prior to ASB Spring Elections and shall be held before inauguration in coordination with the previously stipulated attendees.

D) The President shall be required to present a State of the Student Body Address to the student body at least once during his or her term. The President shall determine the date of the address at his or her discretion, and the event shall be planned by the ASB President. The address shall be given orally at a location on campus as determined by the President.

WHEREAS, ASB and the University of Mississippi student body need to be informed of the Associated Student Body President's goals and progress achieved over his or her term; AND,

WHEREAS, the ASB President would be required to present a State of the Student Body Address to the University of Mississippi student body at least once during his or her term, with the freedom to determine the date of the address;

THEREFORE, BE IT ENACTED THAT THE ASSOCIATED STUDENT BODY SENATE REQUIRE THAT THE ASSOCIATED STUDENT BODY PRESIDENT PRESENT A STATE OF THE STUDENT BODY ADDRESS TO THE UNIVERSITY OF MISSISSIPPI STUDENT BODY AT LEAST ONCE DURING HIS OR HER TERM.
